Terms & Conditions – Customer Competition

1. The competition commences on Thursday 14 August and closes at 9:00am (AEST) on Thursday 28 August at 10.00am.
2. To enter, customers are required to spend any amount at Westside Plaza during the competition period.
3. Only entries submitted on an original Entry Form will be accepted as a valid entry in-Centre, OR via the official online Entry Form with a valid receipt uploaded from a Westside Plaza retailer during the competition period.
4. For an additional entry to the competition, customers can take a picture with the display and tag Westside Plaza on either Facebook or Instagram. The customer's social media profile needs to be set to public for the entry to be found.
5. Each Entry Form is counted as one (1) entry and may not be used more than once.
6. The prize pool consists of a \$500 Woolworths Voucher that will be sent to the winner as an e-voucher.
7. The total prize pool is valued at \$500.
8. Prizes are not transferable or exchangeable for cash.
9. The Prize Draw will take place on Thursday 28 August (AEST) where one (1) entry will be drawn from the physical entry forms and one (1) from the online entries. A final winner will be selected randomly from these two.
10. If a prize (or portion of a prize) is unavailable, the Promoter reserves the right to substitute it with a prize of equal or greater value, subject to any written directions from a regulatory authority.
11. Winners will be notified by phone. If a winner cannot be reached within 48 hours, the prize will be forfeited, and a new winner will be drawn.

14. The Prize winner must collect the prize at Westside Plaza at a time arranged with a representative of the Centre.
